This is the formal application by Nuren Group Limited (the Company) to list its ordinary fully paid securities on the National Stock Exchange of Australia Limited (NSX).

3. Securities

The Company has on issue 5,000 ordinary shares on issue, which were issued on 17 November 2023 to SI Holdings Limited for the consideration of AUD 0.20 per share.

Prior to listing to NSX, the Company will issue 23,403,000 ordinary shares to SI Holdings Limited for the issue price of AUD 0.01 per share, 7,546,000 ordinary shares to Chong Yew Yen for the issue price of AUD 0.01 per share, and 7,546,000 ordinary shares to Chong Yew Phang for the issue price of AUD 0.01 per share to raise of total of AUD384,950 prior to or at the time the offered under the Prospectus. Pursuant to share sale agreements between the Company, Enlinea and shareholders of Enlinea, dated on or around 28 February 2024, a further 109,420,000 ordinary shares in the Company were issued as consideration for the Company's acquisition of 100% of shares in Enlinea. Also, upon the completion of the Offer, the Company will be issuing 3,080,000 Shares to the holding company of its Nominated Adviser, Arris Consulting Sdn Bhd.

As mentioned above, the Company is offering 3,000,000 Shares at an issue price of AUD 0.20 per Share to raise AUD 600,000. Oversubscriptions of up to a further 500,000 Shares at an issue price of AUD 0.20 per Share may be accepted, and the total amount raised for maximum subscriptions will be AUD 700,000.

Therefore, a total of 154,000,000 Shares will be on issue and to be quoted on the NSX upon the completion of the Offer for minimum subscription, or 154,500,000 Shares for maximum subscription.

4. History and nature of business

The Company was incorporated on 17 November 2023 for the sole purpose of acquiring a 100% interest in Enlinea Sdn Bhd ("Enlinea"). Enlinea was incorporated on 2nd March 2012, with the registration number 980617A. Enlinea operates an established and profitable media advertising and e-commerce service businesses, based in Asia. Enlinea is licensed by the Malaysia's Multimedia Super Corridor (MSC) and other professional bodies. It offers incentives and privileges to promote growth in the information and technology sectors and also provides ecommerce services for baby products.

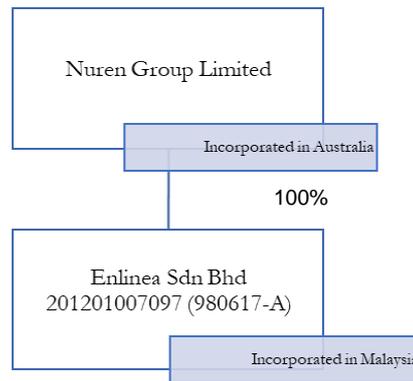

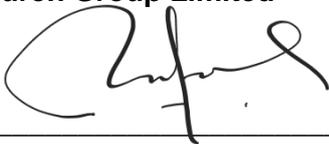
