## **QUARTERLY UPDATE ON ACTIVITIES FOR THE QUARTER TO 30 JUNE 2025**

## **Key Highlights**

- Unaudited sales revenue for the 1<sup>st</sup> Quarter ending 30 June 2025 amounted to \$625k.
- Sales revenue for the quarter was mainly from the domestic market with Ecommerce sales contributing 41% and Media and Advertising fee contributed the remaining 59%.
- Cash at the end of the quarter was \$30k.
- The net cash outflow for the quarter was \$(223k), comprising of:
  - 1) The net cash outflow from operating activities for the quarter was \$51k. During the quarter \$644k in cash receipts were received from customers. There are cash payments related to operating activities amounting to \$702k. These payments mainly comprised:
    - a) Staff costs \$339k.
    - b) Advertising and marketing costs \$270k.
  - 2) The net cash outflow from investing activities for the quarter was \$132k. This is mainly due to the payment of physical non-current assets (\$5k) and other non-current assets (\$135k).
  - 3) The net cash outflow from financing activities for the quarter was \$40k. This is from the repayment of borrowings.

## **Corporate Activities**

• There was no issuance of shares during the quarter ended 30 June 2025. As of 30 June 2025, the company had 154,500,000 listed shares on issue.

### **Payments to Related Parties**

Cash payments for directors' remuneration during the quarter were \$112k.
