As the Company's shares are now ex-dividend, the dividend has been deducted from the net asset value.

As at close of business on 17 February 2017, the unaudited net asset value per share (excluding current financial year revenue items and shares held in treasury) was 785.4p and the net asset value per share with debt marked at fair value was 781.3p.

The Company's debenture is fair valued daily, based on its market value, while loan notes and short term borrowings are valued at par.
