Issue of Ordinary Shares as per the Methven Senior Executive Share Scheme (Scheme), which was offered to an invited executive of Methven.

Terms or details of the issue

100,000 Shares is offered as the long term incentive (LTI) remuneration component to a senior executive, who was promoted to Chief Marketing Officer on 19 December 2016.

As per the Scheme rules, the Issue Price of \$1.3070 per share is at the VWAP for the 10 business days prior to 5 January 2017, being the date this executive became eligible to the Scheme.

The Shares have been issued to Methven Employee Share Trustee Limited (rather than to the executive), who holds the Shares in trust until June 2018. In accordance with the terms of the Scheme, the Shares will not be transferred to the executive until the loan is repaid.

Methyen's Board of Directors believe that the best interests of all shareholders are served when selected senior executives have potential rewards when they contribute to Methven achieving the desired group NPAT targets. For these executives, who are retained in the business until June 2018, a cash bonus may be payable such that this bonus is used to repay all or part of the loan.
