The actual exercise price of each warrant is \$0.63 less the dividends per share declared by the company between 21 November 2016 and 24 November 2017. Dividends totalling 4.00 cents per share have been declared to date and one more dividend is expected to be declared in the remaining period to 24 November 2017.
