What is the purpose of this update?

This document tells you how the NZ Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The NZ Property Fund invests in property assets listed on the NZX Main Board and is designed to track the return on the S&P/NZX Real Estate Select Index.

Total value of the fund: \$55,448,560
The date the fund started: 12 November 2015

What are the risks of investing?

Risk indicator for the NZ Property Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating. 

Example of how this applies to an investor


Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$139 (that is -1.39% of her initial \$10,000).

Tara paid no other charges. This gives Tara a total loss after tax of -\$139 for the year.

Notes
