## What is the purpose of this update?

This document tells you how the Australian Mid Cap Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ## **Description of this fund**

The Australian Mid Cap Fund invests in financial products listed on the Australian Securities Exchange and is designed to track the return on the S&P/ASX Mid Cap 50 Index.

# What are the risks of investing?

Risk indicator for the Australian Mid Cap Fund<sup>1</sup>


## **Example of how this applies to an investor**

Tara had \$10,000 in the fund on 7 November 2016 and did not make any further contributions. On 30 September 2017, Tara received a return after fund charges were deducted of \$2,017 (that is 20.17% of her initial \$10,000). Tara paid no other charges. This gives Tara a total return after tax of \$2,017 for the 10 months and 24 days.
