### **Future Mobility Solutions announces distribution of Offer Document**

Future Mobility Solutions Limited (NZX: FMS) has today sent a copy of the Offer Document and Entitlement and Acceptance Form to eligible shareholders.

The 3.7 million capital raise by way of a pro-rata renounceable 1 for 5 rights issue at \$0.125 per new share, was announced to the market on 24 August 2018 ("Offer").

The issue price represents a 9% discount to a 30 day moving average price on the NZX of NZ\$0.137 as at 23 August 2018.

Proceeds from the Offer will be used by FMS to repay existing debt and for ongoing working capital requirements.

Both the Chairman Eric Series and FMS's CEO Mark Broadley intend to subscribe, through entities associated with them, for their respective full entitlements under the Offer. Additionally, as a further demonstration of support, the balance of the Offer is fully underwritten by an entity associated with Mark Broadley.
