

Orion Health Group Limited Annual Shareholders' Meeting 2018 Results

Auckland, New Zealand, 1 October 2018 – Orion Health Group Limited (NZX:OHE, ASX:OHE) advises that all resolutions put to the company's Annual Shareholders' Meeting held in Auckland on Friday were passed. The matters considered by Shareholders were:

- Approval of the Hg Transaction, as described in the Notice of Meeting.
- Approval of the Share Buyback on completion of the Hg Transaction, as described in the Notice of Meeting.
- Authorisation for the Directors of Orion Health to fix the auditors' remuneration for the financial year ending 31 March 2019.

All resolutions were decided by poll. The details of the total number of votes cast in person, online and by proxy on the polls were as follows:

If the Hg Transaction completes on 31 October 2018, Orion Health anticipates that the final Share Buyback price will be finalised, and materials sent to Shareholders, in November 2018, and that the Share Buyback will be completed in December 2018.
