MEETING NOTES

Resolution 1: Re-election of director Paul McCarney

Paul McCarney was appointed in November 2012, was elected in October 2013 and re-elected in October 2015.

In accordance with the NZX Listing Rules requirements, which mean one-third of the directors must retire by rotation each year, he retires by rotation and offers himself for re-election as a director again this year. The directors are unanimous in their support of Paul standing for re-election.



Paul McCarney Independent director

Paul is the co-founder and CEO of Data Republic (<u>www.datarepublic.com</u>), a business focused on secure data collaboration. He is also co-founder of the data for social good charity, Minerva Collective.

Paul was one of the founders of search marketing agency Decide Interactive (acquired by 247 Real Media in 2004) and digital marketing company Life Event Media (acquired by Sensis in 2011).

At times, he has consulted to Bain and Accenture, and he is a non-executive director of Cirrus Media, and was previously a non-executive director of iiNet.

Resolution 2: Re-election of director Katrina Johnson

Katrina Johnson was appointed to the Board in June 2016, and was elected in November 2016.

She is also retiring by rotation and offers herself for re-election as a director again this year, with the unanimous support of the other directors.

Katrina has a Bachelor of Arts, and Bachelor of Laws (Honours) from Macquarie University and a Graduate Diploma of Legal Practice from the College of Law, New South Wales.

Resolution 3: Auditor's remuneration

Section 207S of the Companies Act 1993 states that the auditor's fees and expenses must be fixed by the company or in the manner that the company determines at a shareholders' meeting. Shareholders are asked to resolve that the directors should fix the auditor's remuneration.

Each resolution is an ordinary resolution, to be passed by a simple majority of the votes of holders of shares which are entitled to vote, and are voted.

Shareholders entitled to attend and vote

If you appoint a proxy, you can either direct your proxy how to vote or let them decide on the day on your behalf. If you do not tick a box for a particular resolution, then your proxy will abstain from voting.
