On 10 December 2018, Global Valar S.L. made a partial takeover offer for up to 75% of the ordinary shares in Restaurant Brands New Zealand Limited at \$9.45 per share. David Beguely procured Tiakarete Pty Ltd as trustee of the Tiakarete Superannuation Fund (of which he is a beneficiary) to accept this offer in respect of all of the shares held by it, as a superior proposal has not arisen as at the date of this notice, and Global Valar S.L.'s offer price is higher than the independent adviser's valuation range for shares in Restaurant Brands New Zealand Limited. This disclosure notice relates to that acceptance, and no actual disposal has yet occurred.
