What is the purpose of this update?

This document tells you how the US Large Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The US Large Growth Fund invests in the Vanguard Growth ETF, which is designed to track the return on the CRSP US Large Cap Growth Index.

Total value of the fund: \$30,692,380

The date the fund started: 29 July 2015

What are the risks of investing?

Risk indicator for the US Large Growth Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

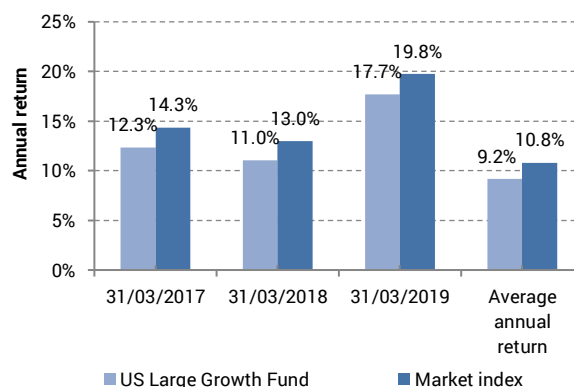

How has the fund performed?

What fees are investors charged?

Small differences in fees and charges can have a big impact on your investment over the long term.

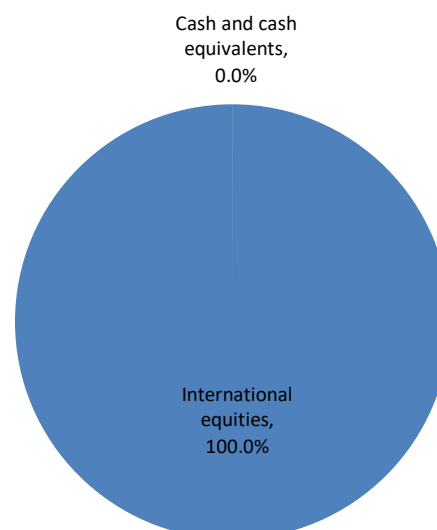
Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$1,772 (that is 17.72% of her initial \$10,000). This gives Tara a total return after tax of \$1,772 for the year.
