#### Fund update for the quarter ended 31 March 2019

This fund update was first made publicly available on 1 May 2019.

## What is the purpose of this update?

This document tells you how the Emerging Markets Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

The Emerging Markets Fund invests in the Vanguard FTSE Emerging Markets ETF, which is designed to track the return on the FTSE Emerging Markets All Cap China A Inclusion Index.

## What are the risks of investing?

Risk indicator for the Emerging Markets Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

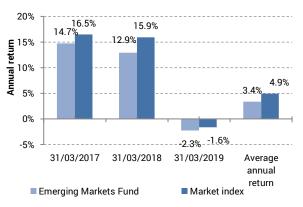
## How has the fund performed?

#### What fees are investors charged?

Investors in the Emerging Markets Fund are charged fund charges. In the year to 31 March 2018 these were:

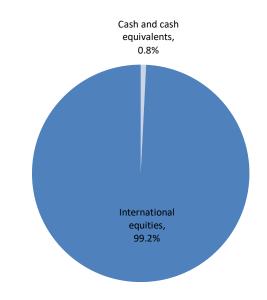
## Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$229 (that is -2.29% of her initial \$10,000). This gives Tara a total loss after tax of -\$229 for the year.
