## Smartshares Emerging Markets ETF

### Fund update for the quarter ended 30 June 2019

This fund update was first made publicly available on 26 July 2019.

### What is the purpose of this update?

This document tells you how the Smartshares Emerging Markets ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Smartshares Emerging Markets ETF invests in the Vanguard FTSE Emerging Markets ETF, which is designed to track the return on the FTSE Emerging Markets All Cap China A Inclusion Index.

Total value of the fund: \$123,307,128

The date the fund started: 29 July 2015

### What are the risks of investing?

#### Risk indicator for the Smartshares Emerging Markets ETF<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

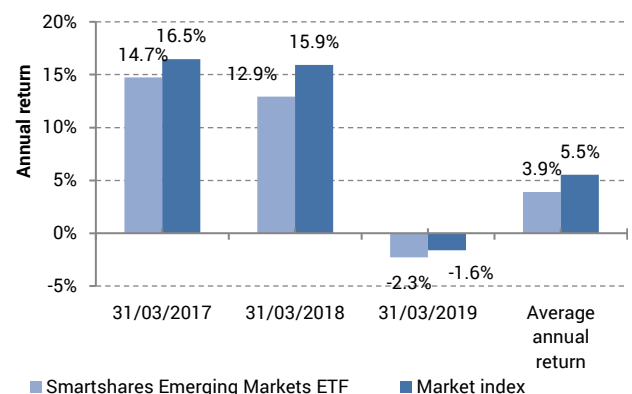

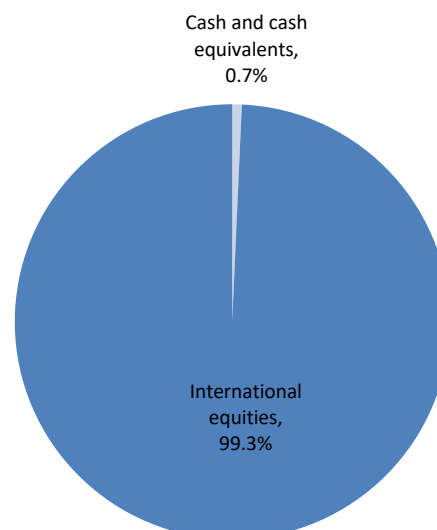
## Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$432 (that is 4.32% of her initial \$10,000). This gives Tara a total return after tax of \$432 for the year.
