What is the purpose of this update?

Description of this fund

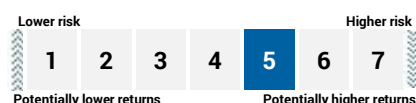
The Smartshares Europe ETF invests in the Vanguard FTSE Europe ETF, which is designed to track the return on the FTSE Developed Europe All Cap Index.

Total value of the fund: \$173,432,115

The date the fund started: 29 July 2015

What are the risks of investing?

Risk indicator for the Smartshares Europe ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

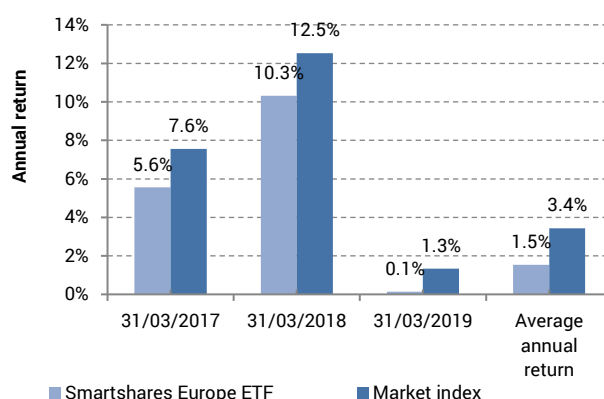

How has the fund performed?

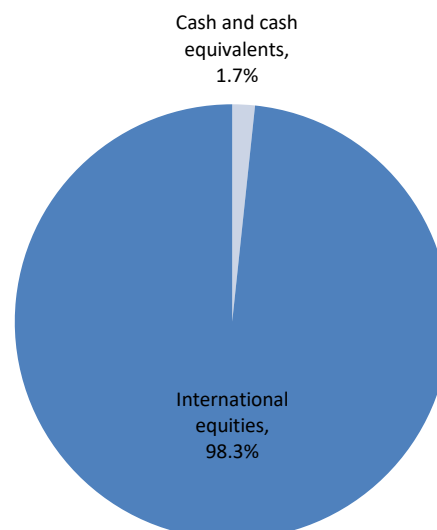
Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$68 (that is 0.68% of her initial \$10,000). This gives Tara a total return after tax of \$68 for the year.
