2019 Annual Shareholder Meeting: Results of Meeting

The Annual Shareholder Meeting (**ASM**) of Genesis Energy Limited (**GNE**) was held in Auckland, on Wednesday 16 October 2019. All resolutions put before the ASM were decided by poll. The number of votes cast in person or by proxy were as follows:

In accordance with NZX Listing Rule 2.6, the Board determined that Timothy Miles, Maury Lelyand Penno, Paul Zealand and Catherine Drayton are independent non-executive Directors. The Board's criteria for determining independence is consistent with the requirements set out in the NZX Main Board Listing Rules.

The Board reconfirms that the other members of the Board, namely, Barbara Chapman, as Chairman, Doug McKay and James Moulder, are independent non-executive Directors.

As communicated to shareholders in August 2019, Joanna Perry has retired as a Director of Genesis, with effect from the conclusion of the ASM.
