What is the purpose of this update?

Description of this fund

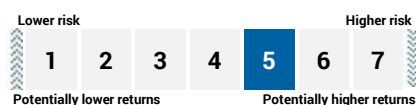
The Smartshares US Mid Cap ETF invests in the Vanguard Mid Cap ETF, which is designed to track the return on the CRSP US Mid Cap Index.

Total value of the fund: \$77,822,490

The date the fund started: 29 July 2015

What are the risks of investing?

Risk indicator for the Smartshares US Mid Cap ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

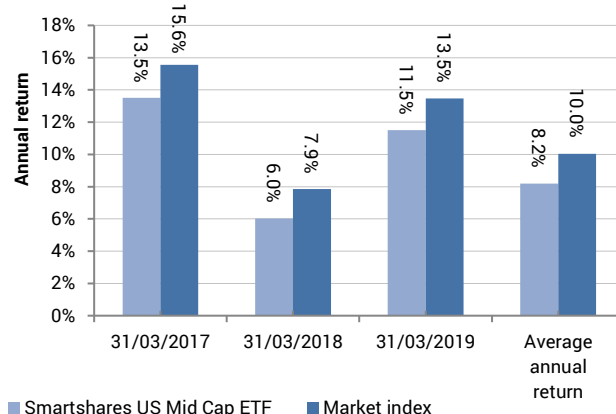

How has the fund performed?

What fees are investors charged?

GST is included in the fund charges set out above.

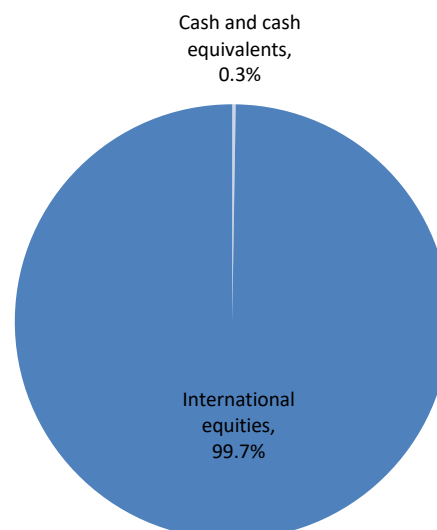
Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$621 (that is 6.21% of her initial \$10,000). This gives Tara a total return after tax of \$621 for the year.

Notes
