	In doing so, Craigs Investment Partners Limited acquired a relevant interest, being the power to acquire and dispose of, or to control the acquisition or disposition of, the shares. A copy of the Block Trade Agreement was attached to the SSH notice filed by OHHL on 29 January 2020. Following the allocation of Oceania shares in the block trade Craigs Investment Partners Limited ceased to have a substantial holding in Oceania.
