# Correction to Notice of Meeting

20 April 2020

We refer to the Notice of Meeting issued 27 March 2020 in respect of the Special Meeting of Shareholders to be held on 29 April 2020 (the "Notice"). On page 6 of the Notice it is stated under the heading "Conditionality" that "The conditions must be satisfied by 30 April 2020. If any of the conditions are not satisfied by this date, then the ASA will not complete unless the Vendors and Verifone agree to an extension". This statement is incorrect. The 30 April 2020 is not a "drop dead" date requiring agreement to extend as implied in the NOM. It is simply a date that either party could (but is not required to) serve a termination notice if the conditions haven't been satisfied by that date, subject to the relevant party not being in breach of its obligations to use its reasonable endeavours to satisfy the conditions.

We confirm that we are continuing to progress the satisfaction of the conditions above which includes proceeding with our Special Meeting of Shareholders to be held at 10:30am NZST on 29 April 2020 to seek shareholder approval for the transaction and continuing to assist with the NZ Commerce Commission process.
