What is the purpose of this update?

Description of this fund

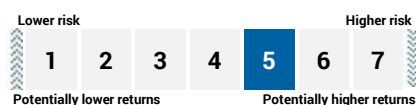
The Smartshares US 500 ETF invests in the Vanguard S&P 500 ETF, which is designed to track the return on the S&P 500 Index.

Total value of the fund: \$226,407,172

The date the fund started: 29 July 2015

What are the risks of investing?

Risk indicator for the Smartshares US 500 ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

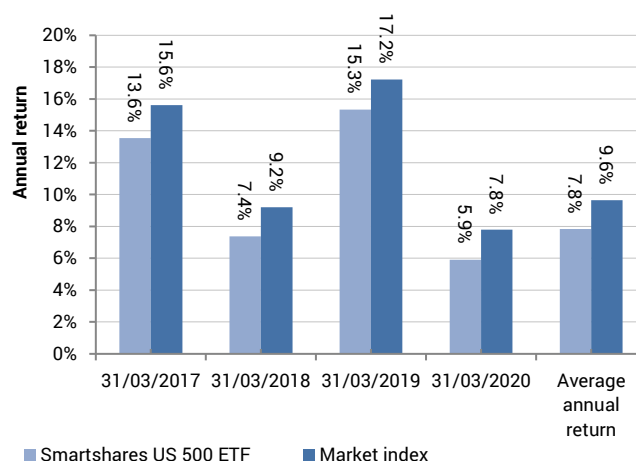

How has the fund performed?

What fees are investors charged?

Investors in the Smartshares US 500 ETF are charged fund charges. In the year to 31 March 2020 these were:

GST is included in the fund charges set out above.

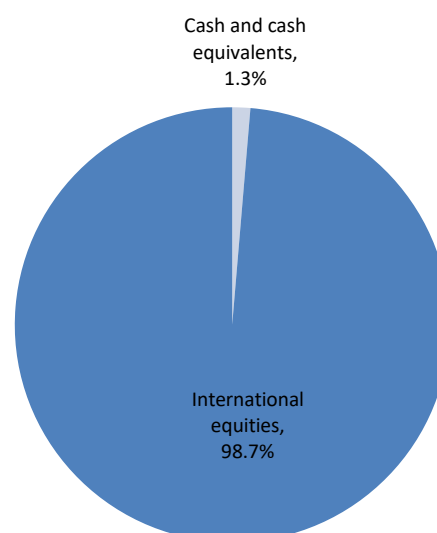
Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$592 (that is 5.92% of her initial \$10,000). This gives Tara a total return after tax of \$592 for the year.

Material changes

There have been no material changes to the nature of Smartshares Exchange Traded Funds, the investment objectives and strategy of the fund, or the management of the scheme over the quarter ended 31 March 2020.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 months of market index returns.
- 2 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
