Rockridge Trustee Company Limited and Mark Edward Francis (**Mr Francis**, together with Rockridge Trustee Company Limited the **Rockridge Trustees**) are the trustees of a trust associated with Mr Francis, a director of Augusta Capital Limited (**Augusta Capital**).

On 29 June 2020, Centuria New Zealand Holdings Limited (**Centuria**) made a full takeover offer under the Takeovers Code to acquire all of the equity securities of Augusta Capital (**Centuria**'s **Offer**).

On 10 July 2020, 759,903 ordinary shares in Augusta Capital were issued to the Rockridge Trustees as described in a capital change notice dated 13 July 2020 (LTI Shares).

On 16 July 2020, 14,743,396 ordinary shares in Augusta Capital held by the Rockridge Trustees and 5,454,545 ordinary shares in Augusta Capital held by Leveraged Equities Finance Limited and controlled by the Rockridge Trustees were transferred to Centuria pursuant to Centuria's Offer.

As a result, the Rockridge Trustees are left with a relevant interest only in the LTI Shares, which have been accepted into Centuria's Offer but not yet transferred to Centuria.

Centuria's Offer provides consideration of NZ\$0.22 in cash plus an issue of 0.392 of stapled securities in Centuria Capital Group per share in Augusta Capital (subject to certain adjustments further described in Centuria's Offer).
