### ANNUAL REPORT FOR THE YEAR TO 31 MARCH 2020

### **Details of Scheme**

This is the annual report for the Smartshares Exchange Traded Funds (**Scheme**) for the year to 31 March 2020. The Scheme is a managed fund.

The Scheme's manager is Smartshares Limited (Smartshares), which is a wholly-owned subsidiary of NZX Limited, and the Scheme's supervisor is Public Trust.

The latest Product Disclosure Statement – Smartshares Exchange Traded Fund – Core Series is dated 15 July 2020 and the latest Product Disclosure Statement – Smartshares Exchange Traded Fund – Specialist Series is dated 15 July 2020. The Scheme is open for applications.
