NZ WINDFARMS LIMITED (NWF): 2021 ANNUAL SHAREHOLDERS' MEETING - ONLINE ATTENDANCE ONLY

NZ Windfarms' published a Notice of Meeting on 28 September 2021 in relation to its Annual Meeting of Shareholders citing that the in-person element of the ASM would only go ahead if allowed under the COVID-19 restrictions and public gathering limits in force for Auckland on the day.

This further update confirms that due to the current COVID-19 restrictions in Auckland, NZ Windfarms regrets it is no longer able to hold this meeting in person and has moved to a <u>virtual</u> only format.

While the date and time have not changed, shareholders can now only attend and participate in this meeting online, at 11am on Wednesday 27 October 2021.

The Te Rere Hau wind farm is located on North Range Road in the Tararua Ranges outside of Palmerston North. The wind farm has 92 turbines with a capacity of 46 MW producing enough clean energy to power about 16,000 homes, or in excess of half the households in Palmerston North. In comparison to generate the same amount of energy, a gas-fired power plant would emit roughly 64,000 tonnes of carbon dioxide, the same as an additional 23,000 cars on the road.
