The Distribution Rate was determined using the following formula: (3 month BBSW Rate + Margin) x (1 - Tax Rate) as follows: 3 month BBSW Rate on 22/12/2021: 0.0725% pa + Margin: 2.9000% pa = 2.9725% pa x (1 - Tax Rate): 0.70 = Distribution Rate: 2.0808% pa The cash amount of the Distribution on each Westpac Capital Note 8 (WCN 8) was calculated as follows: Distribution Rate: 2.0808% pa x Face Value: AUD 100 x days in Distribution Period: 90 / 365 = cash amount of Distribution: AUD 0.5131 fully franked
