\* The undiluted NAV excludes any impact on the NAV of the future exercise of warrants (KFLWG). At 6 April 2022, 79,075,168 warrants are on issue and may be exercised on 18 November 2022. The actual exercise price of each warrant is \$2.03 less the dividends per share declared by the company with a record date between 15 November 2021 and the announcement of the 18 November 2022 exercise price. Dividends totalling 7.22 cents per share have been declared to date and there are two more dividends expected to be declared in the remaining period up to the announcement of the 18 November 2022 exercise price.
