## What is the purpose of this update?

This document tells you how the Smartshares Australian Mid Cap ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in Australian shares and is designed to track the return (before tax, fees and other expenses) of the S&P/ASX Mid Cap 50 Index.

Total value of the fund: \$149,528,768
The date the fund started: 7 November 2016

## What are the risks of investing?

#### Risk indicator for the Smartshares Australian Mid Cap ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


#### How has the fund performed?

## What fees are investors charged?

Investors in the Smartshares Australian Mid Cap ETF are charged fund charges. In the year to 31 March 2022 these were:


## **Example of how this applies to an investor**

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$721 (that is -7.21% of her initial \$10,000). This gives Tara a total loss after tax of -\$721 for the year.
