Fund update for the quarter ended 30 September 2023

This fund update was first made publicly available on 30 October 2023.

What is the purpose of this update?

This document tells you how the Smartshares Emerging Markets Equities ESG ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in emerging markets shares and is designed to track the return (before tax, fees and other expenses) of the MSCI EM IMI ESG Screened Index.

Total value of the fund: \$34,890,508
The date the fund started: 6 June 2019

What are the risks of investing?

Risk indicator for the Smartshares Emerging Markets Equities ESG ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$764 (that is 7.64% of their initial \$10,000). This gives Tara a total return after tax of \$625 for the year.

Notes

- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
- The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
