# What is the purpose of this update?

This document tells you how the Smartshares S&P/NZX NZ Government Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

Invests in New Zealand bonds and is designed to track the return (before tax, fees and other expenses) of the S&P/NZX NZ Government Bond Index.

# What are the risks of investing?

Risk indicator for the Smartshares S&P/NZX NZ Government Bond ETF<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


## How has the fund performed?


# **Example of how this applies to an investor**

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted but before tax of \$-181 (that is -1.81% of their initial \$10,000). This gives Tara a total loss after tax of \$-127 for the year.

## **Notes**

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year and 10 months of market index returns.
- These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- Anna Scott was appointed as Chief Executive Officer of Smartshares Limited on 4 September 2023, and replaced Graham Law, in his capacity as Acting Chief Executive Officer of Smartshares Limited, as a key person that has influence on the investment decisions of the fund.
