What is the purpose of this update?

This document tells you how the Smartshares Global Government Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international fixed interest securities and is designed to provide returns (before tax, fees and other expenses) consistent with the Bloomberg Global Aggregate Treasuries Total Return Index, hedged to the New Zealand dollar.

What are the risks of investing?

Risk indicator for the Smartshares Global Government Bond ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

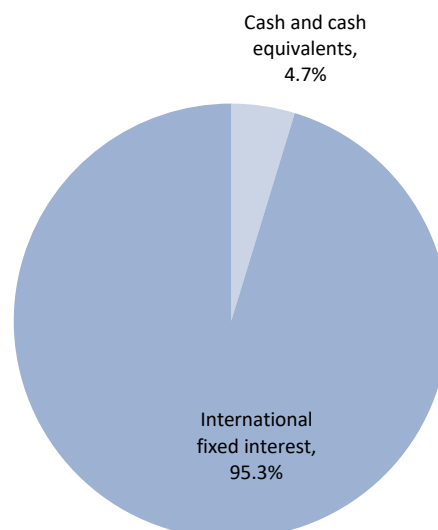
Example of how this applies to an investor

Tara had \$10,000 in the fund on 29 June 2023 and did not make any further contributions. On 31 December 2023, Tara received a return after fund charges were deducted but before tax of \$331 (that is 3.31% of Tara's initial \$10,000). This gives Tara a total return after tax of \$162 for the period.

Currency hedging

As at 29 December 2023 the fund's exposure to assets denominated in foreign currencies was 95.33%, of which 98.95% was hedged. This means the fund's unhedged foreign currency exposure was 1.00% of the net asset value of the fund. Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 6 months of market index returns.
- These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
