### **Details of transactions and events giving rise to ceasing of substantial holding**

Robert William Bentley Morrison has ceased to be a substantial product holder by reason of:

- the issue of 3,652,413 ordinary shares at a price per share of \$10.15 by IFT to various shareholders under a dividend reinvestment plan announced on 21 May 2024, authorised by board resolutions dated 20 May 2024 and 16 June 2024, in accordance with the notice given to NZX by IFT on 25 June 2024 (*DRP*); and
- the issue of 27,093,600 ordinary shares at a price per share of \$10.15 by IFT to various shareholders under a retail offer announced on 17 June 2024, authorised by board resolutions dated 16 June 2024 and 10 July 2024, in accordance with the notice given to NZX by IFT on 16 July 2024 (*retail offer*).

The effect of the issue of those additional ordinary shares by IFT under the *DRP* and the retail offer (in which the registered holders of shares giving rise to the relevant interests of Robert William Bentley Morrison did not participate) is to reduce the relative relevant interests of Robert William Bentley Morrison.
