Proxy/Voting Form

How to Vote on Items of Business

All your securities will be voted in accordance with your directions.

Appointment of Proxy

All shareholders of the Company entitled to attend and vote at the meeting are entitled to appoint a proxy to attend and vote for them instead. A proxy need not be a shareholder of the Company.

If you inadvertently do not name a proxy, or your named proxy does not attend the meeting or you wish to appoint an independent director or the Chairman as your proxy, Mr Sean Joyce (Chairman of BAI) is willing to act on your behalf.

Voting of your holding

Direct your proxy how to vote by marking one of the boxes opposite each item of business. If you do not mark a box your proxy may vote as they choose. If you mark more than one box on an item your vote will be invalid on that item.

If you return this Proxy Form without directing the proxy how to vote on any particular matter, the proxy will vote as he or she thinks fit.

There are no voting restrictions.

Signing Instructions for Postal Forms

Individual
