


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,130 (that is 11.30% of Tara's initial \$10,000). This gives Tara a total return after tax of \$990 for the year.
