# What is the purpose of this update?

This document tells you how the Smartshares Global Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in international bonds, with the objective of outperforming the Bloomberg Global Aggregate Total Return Index Hedged NZD by 1% per annum over rolling 3-year periods, hedged to the New Zealand dollar. The investment manager is PIMCO Australia Pty Ltd.

Total value of the fund: \$157,168,525
The date the fund started: 12 November 2015

# What are the risks of investing?




# **Example of how this applies to an investor**

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$543 (that is 5.43% of Tara's initial \$10,000). This gives Tara a total return after tax of \$391 for the year.

# **Currency hedging**

As at 27 June 2024 the fund's exposure to assets denominated in foreign currencies was 100.52%, of which 100.12% was hedged. This means the fund's unhedged foreign currency exposure was 0.00% of the net asset value of the fund.
