Details of the transactions or other events requiring disclosure:

Various transactions have taken place by interests associated with Christopher Peter Huljich since his last substantial product holder notice dated 14 August 2014, as previously disclosed in his ongoing disclosure notices of 5 June 2015, 5 October 2015 and 20 October 2015. None of these transactions resulted in a movement of 1% or more in his substantial holding, or a change in the nature of his relevant interest in PAY, since 14 August 2014.

As announced to the market on 5 October 2016, Christopher & Banks Private Equity V Limited participated in PAY's AU\$40 million private placement by subscribing for 478,468 additional shares in

PAY. Despite this, Christopher Peter Huljich's substantial holding in PAY has been diluted by the issue of 19,138,756 new shares in PAY under the private placement. That dilution resulted in a movement of 1% or more in Christopher Peter Huljich's substantial holding.
