

## Pushpay commences quotation on the ASX under ticker code 'PPH'

As previously disclosed, Pushpay has changed its NZX ticker code from 'PAY' to 'PPH', effective today, 12 October 2016, in order to ensure that it is able to trade on NZX and ASX using the same code.

Pushpay's shareholders will be able to trade their shares on either the NZX or the ASX. In order to trade on either exchange, shares will need to be registered on the share register for that particular jurisdiction.
