***Trilogy International announces completion of Sociedad Agricola Y Forestal Casino SpA (“Forestal Casino”) transaction***

New Zealand, 1 July 2016 – Trilogy International Limited (NZX:TIL) (“TIL”) today announced completion of the acquisition of a 25 percent stake in Forestal Casino, the largest Chilean based rosehip producer.

As per the terms of the agreement announced on 26 May 2016, the full consideration is USD 8.0 million; USD 2.0 million in cash and USD 6.0 million funded through the issue of 2,615,181 new ordinary shares. The new ordinary shares will be allotted on Monday, 4 July 2016.
