# **Operations Update - Browns Oxide Project**

### Copper

Compass Resources (ASX code: CMR) is pleased to confirm the completion of our first shipment of copper cathode from the Browns Oxide Project with payment for the first 250 tonnes having been received

The next 250 tonnes is expected to be shipped in the first week of January.

### Cobalt/Nickel

Commissioning of the circuit has taken longer than expected, however we expect production of cobalt/nickel concentrate to commence in the next week.

#### Costs

The current weakness in commodity markets is likely to have a positive impact on production costs with input costs likely to fall from previously anticipated levels. We are actively renegotiating all supply contracts.
