At the last General Meeting held in February, we announced the signing of a Heads of Agreement with Mildura-based Thurla Farms for the acquisition of that agribusiness.

There is no doubt the global financial crisis has impacted on our success in funding the Thurla Farms acquisition but it has certainly not affected the determination of both parties to proceed with the deal.

The Board was hoping to have this deal tied down before this AGM; however our options are still being considered. We will continue to pursue funding options to bring this acquisition to a close as soon as possible.

The acquisition deal may not finalised, yet we have maintained a close relationship with Col Beasley – owner of Thurla Farms – and his management team. Our working relationship with Col is very good and where appropriate we continue to share information to ensure our plans for the agribusiness keep moving ahead.

One thing we do know for certain is that everyone at this table is united in the company's decision not to dilute existing shareholders to get the Thurla Farms deal over the line. We will secure the best deal that maintains value for you.

We have had a very steady progression towards returning the Computronic's reputation of reliability and stability to our customers who expect nothing less than cutting edge technology. This has been vital in order to keep trading and make a profit.

We are definitely heading in the right direction and ask our Shareholders to stick with us as the road ahead brighter from where we have been.

There was a Board change during the year with Sean Henbury resigning and our Chief Executive Freeman Wyllie accepting a place on the Board. This was a smooth transition as Sean agreed to remain as Company Secretary, an important position that ensures our corporate governance is maintained at all times.

Freeman has done a remarkable job at the helm of our day-to-day operations over the past 12 months, playing a major role in resurrecting the company in the first six months of his appointment. We are delighted he accepted our offer to join the Board in May, with his considerable expertise and experience in management and the understanding of our business that he brings from his background in information technology and sustainable agriculture.

Doug Townsend is up for re-election in the formal part of this meeting. Doug is a CPA with a strong passion for and experience in the technology and agriculture sectors. He has been a most committed Board member for Computronics since November 2007 and has provided great assistance in the areas of contracts, financing and in acquiring new business, which is essential to our growth as a company. There is an old Chinese proverb that goes: If you stand still, you get run over. That's how we see things at Computronics. The global economy is slowing and is expected to get worse before it gets better. But business for us must push forward. If you track Australia's economy over the past 100 years, our country always comes back far stronger after a period of substantial down-turn.

To top it off most of our core business lies in and around agriculture - an industry where the end product is primarily food. We are operating in a sector which is arguably the most important of this century – sustainable agriculture.

To strengthen our position further in these turbulent economic times, we are also actively engaging in partnerships that will assist us in winning large contracts in the Signs Division. This includes aiming for the big government signage contracts that will go ahead despite the state of the global economy under the Government's commitment to both infrastructure and to awarding tenders with a high local content component. We will also continue to put considerable effort into R&D to ensure we release new innovative and reliable products in a timely manner. This is an area we expect to gradually expand.
