**ISSUE OF AWH CORPORATION LIMITED SHARES SECONDARY TRADING NOTICE
NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT
2001 ("Act")**

The Board of Directors of AWH Corporation Limited ("Company") is pleased to announce the allotment and issue on 9 December 2009 of 56,000,000 fully paid ordinary shares ("Securities") at an issue price of \$0.005 as approved by shareholders at the General Meeting held on 18 September 2009. For further details regarding the background to this share issue please refer resolution 6 of the EGM Shareholder Notice of Meeting released to the ASX on 19 August 2009.

Secondary Trading Exemption

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.

The Company hereby notifies ASX under paragraph 708A(5)(e) of the Act that:

- (a) the Company issued the Securities without disclosure to investors under Part 6D.2 of the Act;
- (b) as at 9 December 2009 the Company has complied with the provisions of Chapter 2M of the Act as they apply to the Company, and section 674 of the Act; and

 - (i) that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules; and
 - (ii) that investors and their professional advisers would reasonably require for the purpose of making an informed assessment of:
 - (iii) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - (iv) the rights and liabilities attaching to the Securities.
