COMPLETION OF SHARE PURCHASE PLAN

C @ Limited (**Company**) is pleased to announce the successful completion of its share purchase plan (**Plan**), as announced on 27 November 2009.

Applications for \$597,000 were received from eligible shareholders for the purchase of ordinary shares in the Company. Successful applicants will be issued the full dollar amount of shares applied for in the Company, at an issue price of \$0.012 per share. The issue price has been determined in accordance with the terms and conditions of the Plan.

A total of 49,750,000 ordinary shares will be issued pursuant to the offer, as per the attached Appendix 3B, representing 78% of the shares available under the Plan.

The proceeds from the Plan will be used to undertake due diligence work on Core Mining Limited (Core) and its assets, and will also be used to provide Core with a debt facility to support planned exploration work at the Avima Iron Ore Project, located in the Republic of Congo.


