CGI Acquires Century Hill Pty Ltd

The Company advises that it has finalized arrangements to acquire 100% of Century Hill Pty Ltd ("Century Hill") resulting in it being a wholly-owned subsidiary.

The consideration for the acquisition is 1,000,000 Shares in the Company.

Century Hill has four exploration licences in the Northern Territory which are believed to have potential to host phosphate mineralization. These licences are within the Daly Basin and one within the Georgina Basin in which Cambrian and Ordovician marine clastic and carbonate sediments are considered prospective for phosphate mineralization.
