## SYNERGY PLUS FINALISES THE LEADING SOLUTIONS ACQUISITION

### Expanding the business on the east coast

**Perth, Western Australia, 25 November 2009** – Synergy Plus Operations Pty Ltd, a wholly owned subsidiary of ComputerCORP Limited (ASX: CZP), has announced today that it has finalised the Business Sale Agreement in respect of the acquisition of Leading Solutions business and assets from the administrators of Leading Solutions.

Further to the announcement on 13 November 2009, Synergy Plus has formalised the purchase of the Leading Solutions business and assets. The acquisition includes the business of providing IT equipment and services trading as Leading Solutions and the associated goodwill. The assets acquired include all plant and equipment, stock, benefit of any business contracts and trade debtors, records and current purchase orders.

Synergy Plus has conducted the Leading Solutions business since 16 November 2009 under the memorandum of understanding with the administrators. The acquisition is scheduled to complete under the Business Sale Agreement on 2 December 2009, subject to third party releases.

As announced previously, the acquisition is in line with the IT Services Integrator's strategy to significantly increase its enterprise business on the East Coast.

Peter Cappendell, Acting Chief Executive Officer of ComputerCORP Limited, said that the Synergy Plus business objective is to have more than 60% of its revenues on the East Coast and this is one step towards achieving this outcome.

"Leading Solutions has been an established business in the enterprise space for 19 years with a very loyal customer base and committed team. We are excited about integrating the Leading Solutions' engineering capabilities with our existing service offerings," Mr Cappendell said.

Synergy Plus will now have approx 320 IT professionals in 11 locations providing services ranging from desktop break/fix all the way to enterprise data centre management, including mid range systems, virtualisation and unified communications. Synergy Plus will also continue to grow its managed services and outsourcing business.

The Company is continuing to service Leading Solutions' existing Clients and Service Contracts.
