## COMPUTERCORP LIMITED CHANGES ITS NAME TO SYNERGY PLUS LIMITED

## Unified company name and branding reflects expansion and business objectives.

ComputerCORP Limited (ASX: CZP) has finalised the changing of its name to "Synergy Plus Limited" (ASX: SNR).

Shareholders have approved the change of the company name to Synergy Plus Limited and the new company name has been registered with ASIC effective 26 November 2009. The Company will no longer trade as ComputerCORP. This move is in line with the rebranding of the operating subsidiary ComputerCORP (Operations) Pty Ltd to Synergy Plus Operations Pty Ltd.

The trading code for the Australian Securities Exchange (ASX) will change to "SNR" effective from Tuesday, 1 December 2009 and the Company's securities will trade under "SNR" from that date.

Peter Cappendell, Acting Chief Executive Officer of Synergy Plus Limited, said the alignment of the new Synergy Plus brand and the company name "Synergy Plus Limited" comes at an exciting time.

"This will allow us to reflect our strategy of combining the enterprise level focus of the Synergy business and the existing diverse solution set of ComputerCORP," Mr Cappendell said.

Synergy Plus now employs 320 full time IT professionals across 11 locations. Synergy Plus provides end-to-end services ranging from desktop break/fix all the way to enterprise data centre management, including mid range systems, virtualisation and unified communications. The Company continues to grow its managed services and outsourcing business through a diversified growth strategy and is on target to increase the business in the east coast from last year's 30% to 60% of total revenue.




