**Everest Financial Group Limited (EFG)**

**New Issue of Securities**

Everest Financial Group (EFG) has granted 16,400,000 options to employees under the existing Employee Option Plan Rules. These options vest in tranches over 5 years, subject to achieving Total Shareholder Return (TSR) based performance hurdles. The details of the options are included in the attached Appendix 3B.

In addition, the Board has recommended that 6,000,000 options be issued to Everest's CEO, Jeremy Reid, subject to shareholder approval. This will be sought at the next General Meeting of EFG. If issued, these options will have the same terms and conditions as those issued to other employees.

Total ordinary shares on issue and quoted on the ASX are 251,442,316.
