Address to Shareholders by Chairman, Ian Smith

"I am very pleased to stand before you today as Chairman of engin and report on what has been a pivotal year for your company. It has been an extraordinarily busy and productive year which has seen the company complete a major restructure, install a new management team and, for the first time, as committed to you at our last AGM, report both a positive operating profit and positive operating cash flows in the second half of the year.

The structural changes, across almost the entire organisation, have significantly reduced the cost base, improved operational efficiencies and lifted customer service levels. These changes have resulted in a lean and focussed organisation which has in turn demonstrated that it can deliver profitable growth. In addition, the engin business now operates off a much-strengthened capital base, has a highly focused and committed management team and is now positioned, better than ever, to deliver growth and greater value to you, our shareholders.

Let me briefly address a few of the specific results the company has achieved in the last fiscal year.

For the half year to June 09, the company achieved a Positive Operating Profit of \$0.1m.

In the same period engin achieved a Positive Operating Cash Flow of \$0.1m.

Subscriber growth of 6% was achieved vs FY08

A new Naked DSL service was launched which attracted 1,400 new subscribers, and

Your company launched a range of innovative new products and services which, during recent challenging economic times, have allowed your company to deliver these impressive results.

Importantly, from a cash perspective, we have increased our cash balance in the second half to \$4.3m.

The future looks increasingly bright for engin. The company has now established a balanced and robust structure with the capacity to grow through both increases in customer numbers as well as new revenue opportunities through new services and new target markets . Both the Board and Management have an absolute commitment to ensuring that this future growth is both profitable and enduring.
