#### **ESPREON BOARD CHANGES**

SAI Global Limited ("SAI") has now secured a 62.5% relevant interest in Espreon Limited ("Espreon" or the "Company") at the conclusion of its takeover offer. In accordance with SAI's intentions as set out in its Bidder's Statement, Mr Tony Scotton (Chief Executive Officer of SAI) and Mr Geoff Richardson (Chief Financial Officer of SAI) have been nominated to join the Espreon Board. The Espreon Board has agreed to accept these nominations and their appointments as Directors of the Company are effective as of today.

Following these appointments, Messrs Ian Payne and Roger Amos and Ms Judith Stack have resigned from the Board. Mr Phil Anderson continues as an independent non-executive Chairman of the Company.

In addition, Messrs Iain Keddie and Hean Siew have retired as Joint Company Secretaries and Ms Hanna Myllyoja has been appointed as Company Secretary to Espreon.
