FCS & FOUR to leverage management resources & delivery capabilities

4C Security Solutions Limited (ASX: "FCS"), a leading provider of security access control and smart card based technologies, is pleased to announce that it has entered into an Operational Alliance and key agreements with 4C Controls Inc., (Nasdaq OTCBB: "FOUR") and Anastasios Angeloglou (Chief Executive Officer), that will see the two corporations leverage their customer, integration, and delivery, capabilities across the GCC (Middle East) and the Asia-Pacific Region.

Operational Alliance

FCS and FOUR intends to leverage their joint resources for mutual benefit. FCS will be the exclusive provider of its access control solutions to FOUR projects which will generate new revenue streams for FCS. FOUR intends to leverage FCS' local market position and delivery capabilities to deliver its pipeline of current projects within the GCC and the Asia-Pacific Region and service key customers in the future.

Group CEO Role

The CEO Services Agreement is for the period 5 February 2009 to 30 June 2011 and may be terminated by either party by proving four (4) months written notice. Other terms and conditions are consistent with an agreement of this nature.

Group Management Resources:

As part of the Operational Alliance, FCS has entered into a Services Agreement with FOUR such that several of its current employees will become part of the FOUR management and delivery team. Under the terms of the Management Services Agreement, FOUR will utilize the UAE team of FCS to provide project management and customer service, covering approximately 80% of these employees cost to FCS. FOUR will also benefit from the FCS local licence in the UAE to provide solutions directly to its clients in Dubai.



The Management Services Agreement is for the period 5 February 2009 to 30 June 2011 and may be terminated by either party by proving four (4) months written notice. Other terms and conditions are consistent with an agreement of this nature.

Mr. Anastasios Angeloglou, Group Chief Executive Officer, said "I am pleased that we have been able to continue to drive value for the stakeholders of FCS from our close commercial relationship with FOUR. The potential of projects developed by FOUR will definitely enhance FCS' revenues. They have recognised FCS' strengths, both product and management, and the agreements to leverage our joint resources will greatly assist FCS".
