Security holders approve Canada Pension Plan Investment Board proposal

Macquarie Communications Infrastructure Group (MCG) is pleased to advise that, at the following meetings:

- Macquarie Communications Infrastructure Limited (MCIL) scheme meeting; (a)
- Macquarie MCG International Limited (MMCGIL) scheme meeting; (b)
- Macquarie Communications Infrastructure Trust (MCIT) trust scheme meeting: (c)
- (d) MCIL general meeting;
- (e) MMCGIL general meeting; and
- (f) MCIT trust general meeting,

(together, Scheme and General Meetings), MCG security holders voted to approve all resolutions required to permit the implementation of the proposal by Canada Pension Plan Investment Board (CPPIB) whereby CPPIB will acquire MCG stapled securities by way of interconditional Schemes of Arrangement and a Trust Scheme.

Details of the voting on the resolutions are attached to this announcement. All resolutions were passed by majorities exceeding those required. Macquarie Group entities did not vote at any of the Scheme and General Meetings other than where the interest they held in MCG securities was held on behalf of a third party who provided voting instructions.

The Supreme Court of Bermuda will now be asked, at a hearing scheduled for 2 July 2009, to sanction the MMCGIL scheme of arrangement.

In addition, the Supreme Court of New South Wales will be asked, at a hearing scheduled for 3 July 2009, to:

- (a) approve the MCIL scheme of arrangement; and
- (b) provide judicial advice in relation to the MCIT trust scheme.

¹ As previously announced, CPPIB also proposes to acquire MCG's manager, Macquarie Communications Infrastructure Management Limited (MCIML) by way of a separate inter-conditional transaction, and in conjunction with that acquisition, to acquire MCIML's entire holding of approximately 18.3% of MCG stapled securities.

If the relevant approvals and advice are provided, the schemes are scheduled for implementation on 21 July 2009.

MCG will apply to the ASX on 7 July 2009 for a voluntary suspension of trading in MCG securities.
