

Padbury Mining Engages New Team To Undertake Regional Evaluation of Peak Hill Project

Highlights:

- Padbury Mining engage Salient and Resource Potentials to undertake regional desktop evaluation across the Peak Hill project area
- Historical exploration data, assay results, rock chips, geophysics data and HyMap hyperspectral imagery to be reviewed to determine areas of further investigation
- > Further field exploration to be conducted by means of surface sampling and detailed mapping
- Results are expected to crystallise the value of its Peak Hill project and to provide Padbury Mining with a major input to its strategy going forward



The Directors of Padbury Mining are pleased to announce that in line with the Company's strategic review and project evaluation strategy, Salient Group Pty Ltd (Salient) and Resource Potentials Pty Ltd (Resource Potentials) have been engaged to conduct a regional geological review of the Peak Hill District, with



emphasis on defining hematite and magnetite potential. Exploration data will be compiled and analysed to further determine the presence of mineralisation across multiple commodities.

Background

The Peak Hill Iron Ore Joint Venture represents a strategic relationship between Padbury Mining Limited ("Padbury") and Aurium Resources Limited ("Aurium"). A total land area in excess of 2,000 km² is covered by the Joint Venture (70% Padbury, 30% Aurium).

The project is located in the Mid West region of Western Australia, 100km North of Meekatharra.

Over 100km of highly prospective strike length, has been identified by means of drilling;, airborne magnetics; HyMap imagery; rock chip sampling and mapping. The Joint Venture partners are employing cost effective modern exploration methods to advance the Peak Hill Iron Project and maximise shareholder value.

The project area lies adjacent to Sino Steel Midwest's Robinson Range Project. Substantial ground positions are held by Cliffs Asia Pacific, Atlas Iron and FMG within close proximity to the Peak Hill Iron Project.

Salient
