## WALLOON COAL MEASURES COAL SEAM GAS DRILLING REPORT, PL171, SURAT BASIN QUEENSLAND.

Victoria Petroleum NL (Vicpet) has been advised by Queensland Gas Company Limited (QGC) that core drilling operations are in progress in the Walloon Coal Measures in PL 171, in the Surat Basin. Two drilling rigs are on location carrying out coring and drill stem test operations at the Lawton #3 and Lawton#4 core holes.

The Lawton core holes are the first wells to be drilled by QGC in PL171 and are the start of a planned exploration and appraisal drilling program of up to 11 wells over the next 12 months to continue the evaluation of the coal seam gas bearing potential and deliverability of the Walloon Coal Measures.

PL 171 is interpreted to be situated in the prime Walloon Coal Seam Gas fairway on the western side of the Surat Basin.

Drilling reports will be provided to the ASX on a weekly basis and as significant events occur.

Commenting on the start of coal seam gas drilling operations in PL171, Vicpet managing director, John Kopcheff said:

"Vicpet is pleased that drilling operations are underway in PL171 to evaluate that permits interpreted resource of 116 petajoules (PJ) of gas in place net to Vicpet. The aim of the drilling program is to establish an initial 2P and 3P coal seam gas reserves base for PL 171.

"Added to Vicpet's CSG interests in ATP 574P and the Don Juan Project Surat Basin, Vicpet is confident of significant future value in its CSG holdings with its interest in a gross 2 trillion cubic feet in place CSG resource."

Victoria Petroleum N.L., holds a 20% interest in PL 171.
